CONTEMPT ORDER

THIS CAUSE came to be heard on the Verified Petitions for Rule to Show Cause filed by the Plaintiff, Elizabeth Holtzman ("Mother"), against the Defendant, James R. Sisco ("Father"); and

IT APPEARING that a trial on Mother's Verified Petitions was held on October 18, 2022 where both parties and witnesses testified and submitted evidence to the Court; it is therefore

ADJUDGED AND ORDERED that

1. Father is found to be in contempt of court for his failure to abide by the terms of the parties' Custody and Visitation Order and Final Order of Divorce, that incorporates the Property Settlement Agreement between the parties.

2. Father is in contempt of court for his violations of the Custody and Visitation Order regarding his continual contacting of Mother absent a bona fide emergency relating to the children, his contacting the Children outside the parameters of the Custody and Visitation Order, and his discussing legal matters, visitation terms, and his disparagement of Mother during the Skype visitation calls with the parties' minor children.

3. Father is in contempt of court for his failure to reimburse Mother for unreimbursed medical expenses of the minor children pursuant to the Final Order of Divorce. Father is to pay Mother \$12,656.55 representing the amount of unreimbursed medical expenses owed to Mother as of September 18, 2022. (Attachment A).
4. Father failed to timely make the first monetary award payment to Mother of \$115,000.00 pursuant to the Property Settlement Agreement, that was due at the end of May 2022. Father did make this payment, approximately one month late.
5. Father shall pay directly to Mother attorney's fees in the amount of \$28,029.00.
6. Father shall be subject to the below plan to purge his contempt, to wit:
  - a. Father shall hold a meeting with his attorney to review the entirety of the Custody and Visitation Order, Property Settlement Agreement, and Final Order of Divorce. During this meeting, Father's attorney shall explain the requirements of the orders and agreement to Father.
  - b. Upon completion of the meeting between Father and his attorney, Father shall submit a signed and notarized affidavit to the Court wherein he certifies he has held the above referenced meeting with his attorney and fully understands the Custody and Visitation Order, Property Settlement Agreement, and Final Order of Divorce and shall abide by the terms therein.
  - c. Father was to sign the title of the Volkswagen Atlas over to Mother before leaving the Court on October 18, 2022. Father did execute the title before leaving the Court.
  - d. Father shall pay \$28,029.00 as and for Mother's attorney's fees and \$12,656.55 in unreimbursed medical expenses, totaling \$40,685.55. Father shall pay this sum in

payments of at least \$2,000.00 per month, directly to Mother, commencing November 1, 2022, and each month thereafter, until the total amount owed has been paid.

e. Father is to contact Tricare as soon as possible to ensure the children are covered by Tricare. Father shall provide Mother with proof of such coverage. Father shall provide such proof of coverage to Mother within thirty (30) days of entry of this Order.

7. The parties completed the attached personal property list regarding the division of personal property items to be divided that remain in the former marital residence. (Attachment B). The items on the list with the initial "JS" next to them shall become the sole and separate property of Father. Items with no initials next to them or with the word "Liz" next to them shall become the sole and separate property of Mother. Mother shall make arrangements to have Mother's personal property items listed on Exhibit B packaged and shipped to Mother. By or before November 4, 2022, the parties, via counsel, shall agree to a date the property packaging and shipment is to occur.

8. Upon completion of the contempt purge plan, including making all payments described above, the submission of the affidavit, transfer of personal property, and all other conditions are met, Father may petition the Court to remove the finding of contempt against him.

9. A copy of the Court's ruling transcript is attached hereto and made a part of this Order.



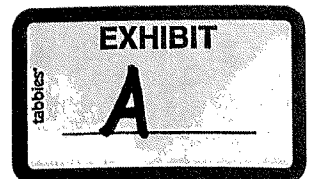

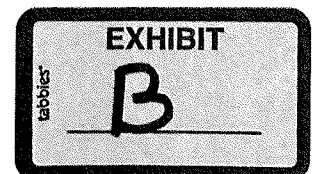
